UPDATE FROM THE JOINT RA & RSG 8 JUNE 2021 MEETING

1. Noticeboards

Awaiting installation of the third noticeboard which will be located by Alton Court Harp Road corner and Copley Close under tree.

Height of the other two noticeboards are an issue. Hub is waiting for panel legs to arrive. **LL** to update.

2. Dropped Curbs, Highways and parking

LL emailed Highways.

Ealing applied for funding to TfL for dropped kerbs and tactile paving at various locations on the estate to ensure there are adequate facilities for the less abled people (wheelchair users etc) to be able to travel safely. Funding has been paused and substantially reduced. Highways officers to look at locations with the intention of installing the dropped kerbs and tactile paving at the main junctions (might not be able to install tactile paving at minor junctions). Process to start from July onwards after identifying funding. **Item** for RA & RSG Agenda 14 September

3. Rubbish bins location

If the bin issue is caused by cars blocking access to bin stores, caretakers should be given the use of pop-up traffic cones to deter car owners to park their cars in front of that space the night before. A letter should be sent/hand-delivered to all the residents in that part of the Close explaining that the Council is monitoring the situation and explaining the action that will be taken, i.e. asking car owners to comply and report any instances where residents are not complying to the Council who will investigate. This solution will avoid the possibilities of missed collections. **LL** to ask LB if the caretakers are able to do that.

LL to ask for article to feature in the Newsletter Summer edition. **LL** to send a copy to PPCR once it is drafted.

4. Abandoned Cars

Hub carrying out MOT and Tax checks. Team to contact car and motorbike owners to give them a chance to remove their vehicles. **LL** to give update.
